



Reference 1 – First Request to Remove the Home Page

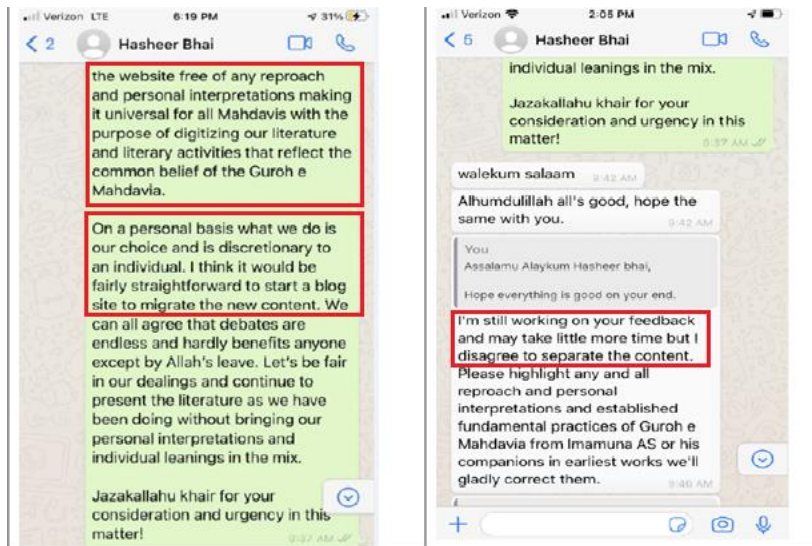

Reference 2 – Second Request to Hasheer to remove the Homepage

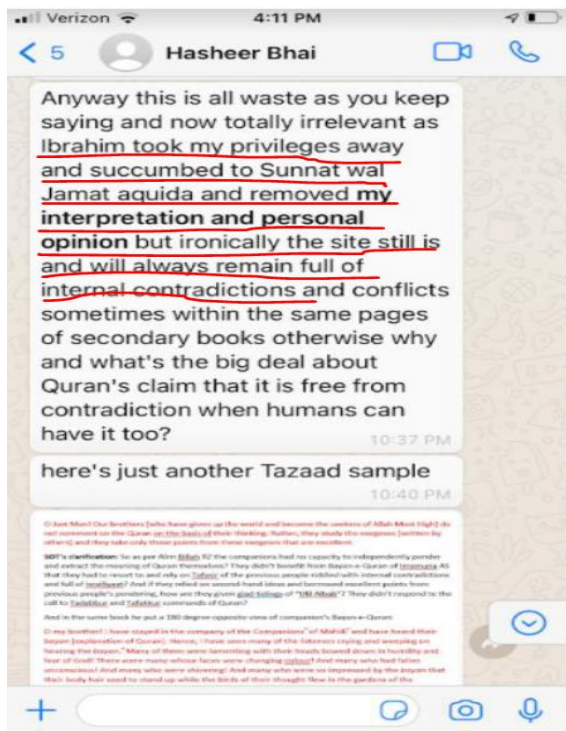

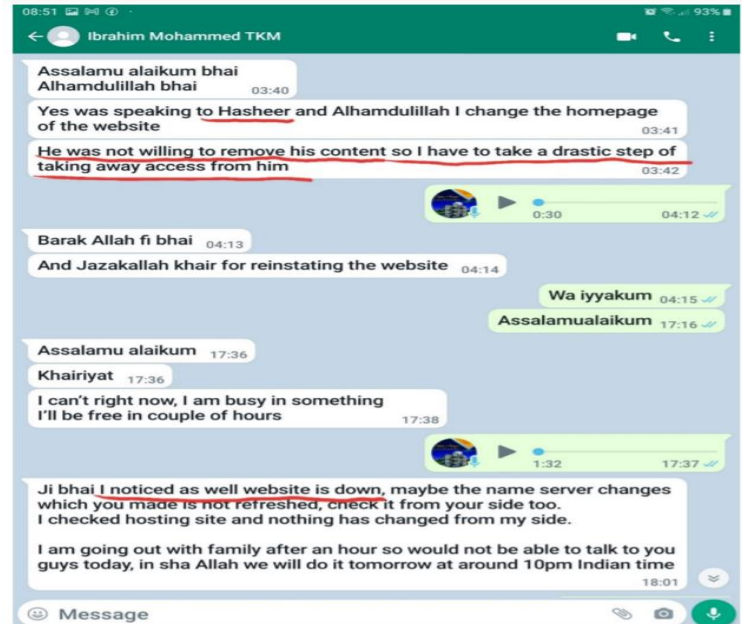

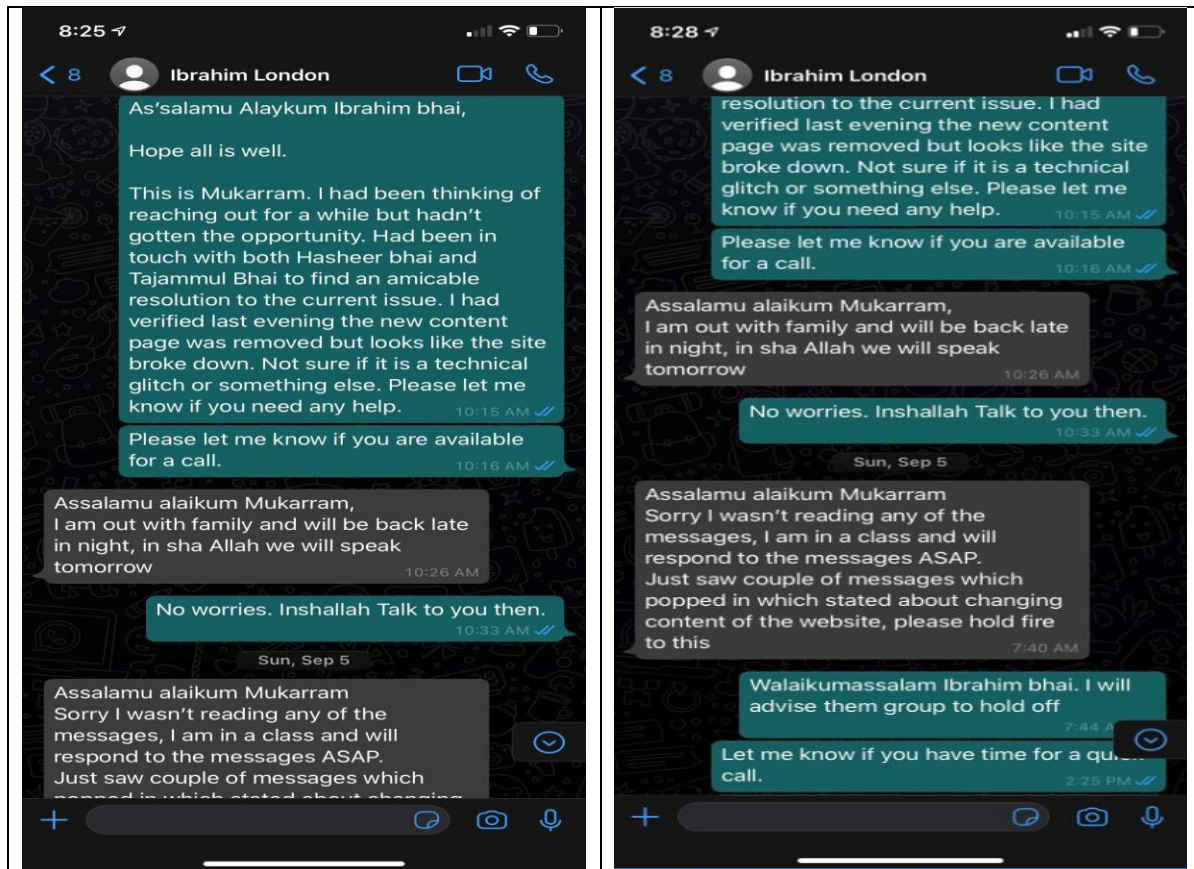
Reference 4 – Hasheer acknowledging Ibrahim Sahab removed him and his Page



Reference 5 – Ibrahim Sahab Removed Hasheer Sahab and the Page was replaced. The website went down after a couple hours due to Technical Issues.



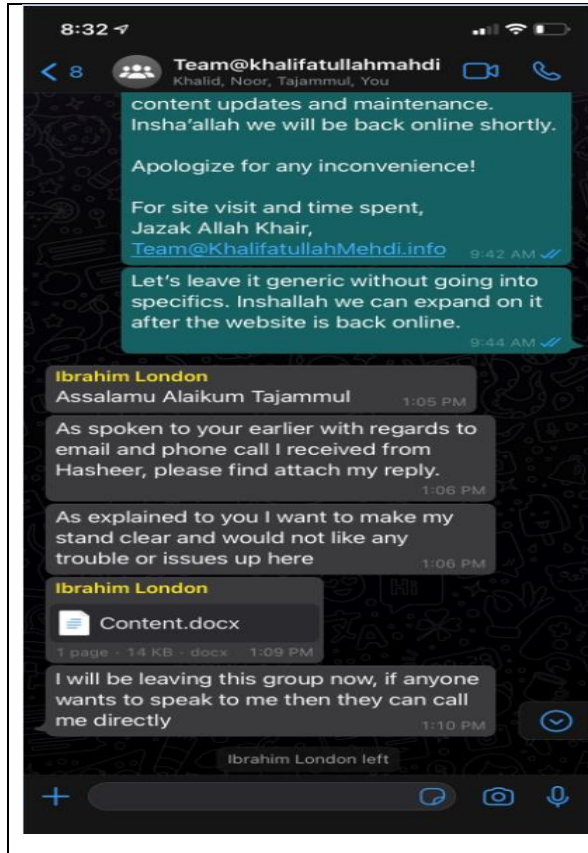

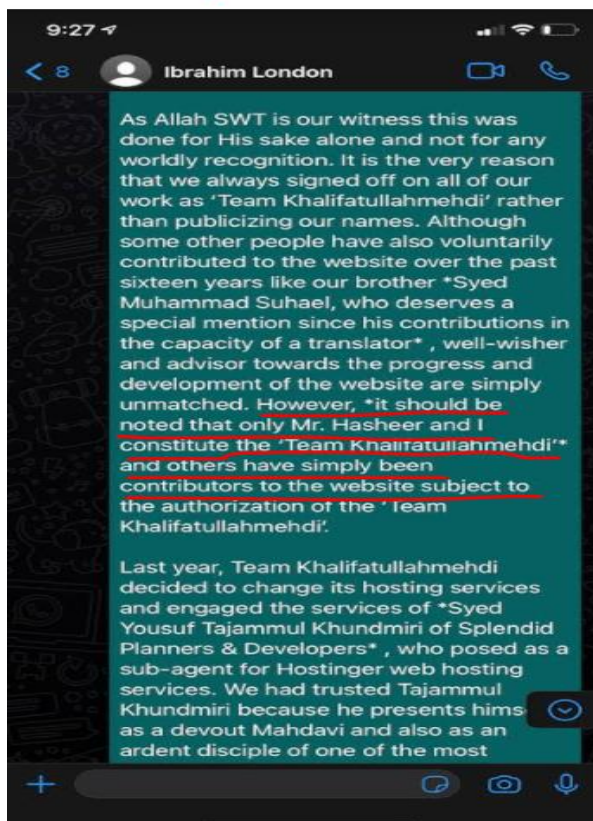
